Ione S. Brown Memorial Scholarship Fund Guidelines Revised February 2020

I. Eligibility

- A. All scholarship applicants must be **members** of Second Baptist Church and a regular participant in an organization, youth activity or worship services at Second Baptist Church.
- B. Persons who have forfeited their scholarship award in the previous year are ineligible from applying during the current year.
- C. Persons are only eligible to receive a scholarship award a total of four (4) times.
- D. Applicants may apply for a scholarship in one of the three (3) following categories:
 - 1. A high school graduating senior who has been accepted for admission (as a full time student) to a college, university, community or technical/vocational college:
 - a. Must have a cumulative 2.0 GPA (on a 4.0 scale)
 - b. Submit the following information:
 - ➤ A completed application
 - > Three letters of recommendation (see section E. on page 3 for explanation)
 - > Official school transcripts
 - > Recent individual photograph (no group pictures)
 - 2. A full-time undergraduate college student in good standing:
 - a. Must maintain a cumulative 2.5 GPA (on a 4.0 scale)
 - b. Submit the following information:
 - A completed application
 - ➤ Required letter(s) of recommendation (see section E. on page 3 for explanation)
 - > Official school transcripts
 - > Recent individual photograph (no group pictures)
 - 3. A seminary student pursuing a degree as a Christian Service Professional. First year seminarians will not be considered.
 - a. Must have a minimum cumulative 2.5 GPA and agree to other specifically prescribed guidelines.
 - b. Submit the following information: (see page 5 for requirements)

- ➤ A completed application
- ➤ Three letters of recommendation (see section E. on page 3 for explanation)
- Official school transcripts
- ➤ Recent individual photograph (no group pictures)
- c. An interview may be required as a part of the selection process.

E. Letters of Recommendation

All letters of recommendation must be from an **independent third party** (i.e., non-relative) inclusive of their name, job title (for #2 and #3), and day or evening phone number.

PLEASE NOTE:

- First time applicants are required to submit three (3) letters of recommendation.
- > Continuing applicants are required to submit one (1) letter of recommendation from a current teacher, counselor, dean or other school professional staff.
 - 1. At least one letter of recommendation must show evidence of continuous attendance, participation, and/or involvement at Second Baptist Church.
 - 2. At least one letter should be from a current teacher, counselor, dean, or other school professional staff.
 - 3. The third letter may be from either of the sources named above, or from a legitimate place of community service, extra-curricular activity and/or employment.

F. Application Materials

- 1. A completed application may ONLY be submitted via the following:
 - ➤ Hand delivered to Scholarship Chairperson
 - ➤ Hand delivered to Ladies Auxiliary church mailbox
 - Sent via U.S. Post Office. (Faxed and/or e-mailed copies WILL NOT be accepted.)
- 2. Transcripts and letters of recommendation may be sent directly from the school to Second Baptist Church at the address listed above, attn: Scholarship Chairperson. (See EXHIBIT A for an example of a transcript.) However, it is the **applicant's responsibility** to ensure receipt BEFORE the deadline.
- 3. Recent **individual** photograph (**no group pictures**)

II. Scholarship Award Distribution

A Required Documentation

1. Student must submit either class schedule or a letter of verification/enrollment from the Registrar's Office for the upcoming semester/quarter.

B. Award Deadline

- 1. Documentation (as described in Section A above) must either be submitted to the Scholarship Chairperson or post-marked to the address listed above no later than January 31, 2021.
- 2. Awards not claimed by January 31, 2021, will be forfeited.

APPLICATIONS MUST BE SUBMITTED EITHER BEFORE OR ON THE DEADLINE DATE AND TIME. APPLICATIONS AND/OR ADDITIONAL INFORMATION SUBMITTED SUBSEQUENT TO THE DEADLINE WILL NOT BE CONSIDERED!!!

III. Financial Awards

A. Scholarships

- 1. Scholarships are awarded annually from the Ione S. Brown Memorial Scholarship Fund. Decisions made by the Scholarship Committee are final and confidential.
- 2. An amount will be set aside yearly for seminarians who meet all requirements.

IV. Presentation Awards

A. Scholarship recipients will be announced publicly at the Unity Tea. The actual monetary award will be issued upon receipt of required documentation outlined in Section II above.

Professional Christian Service Scholarship

(NOTE: This award is for seminary students only. If you are not applying for this award, please be sure to remove this page from your application packet upon submission.)

- 1. Scholarship applicants must be **active members** of Second Baptist Church.
- 2. The applicant must have demonstrated leadership of service in a ministry at Second Baptist Church.
- 3. This applicant must be enrolled as a seminary student pursing a degree as a Christian Service Professional. First year seminarians will not be considered.
- 4. A written statement must be submitted by the applicant that identifies ways in which he/she serves in a meaningful leadership role while still enrolled at a seminary. This service to Second Baptist Church will consist of developing, organizing, and directing a project, mutually agreed upon by a committee of one representative each from the pastoral staff, the diaconate, and the laity of the church.

When applicable and appropriate, permission may be granted for the student to use information from the project as a class paper or project at the seminary. (Permission must be granted by the senior pastor and the advising committee.)

5. Persons are only eligible to receive a scholarship award a total of four (4) times.
